RICHLAND LUTHERAN CHURCH CONGREGATION COUNCIL MINUTES

March 13, 2018

Opening: The regular monthly meeting of the Richland Lutheran Church Congregation Council was held on Tuesday, March 13, 2018, at 7:00 p.m. and opened by the president, Dave Larkin. Janet Budzeck provided the devotions and prayer.

Communications/Visitor Comments: Pam Hedges shared the results they received from questionnaires sent out asking for a summarization of other entities experiences with Quality Sign Services, to which the results were all positive. Pam also provided specific details on the reader board, as well as a preliminary partial cost estimate to replace the existing sign on the corner of Stevens and Van Giesen. After council discussion concerning the project and its complexity, as well as gaining congregational acceptance, a motion was made, seconded and passed to move forward with the pursuit of a 12mm pixel two-sided reader board from Quality Sign Services. There was council discussion and questions on the complexity of this project and how to get congregational acceptance. Dave said he would have to check the policies. Pam will meet with the Foundation Board to find out if they will approve a grant to pay for all or some of the reader board. Future council discussions will address their financial obligation based on the Foundation Board's decision.

After discussing the proposed description, a motion was made, seconded and passed approving the job description with one change – the first bullet under Conditions remove the words "Washington State" before driver's license.

- The motion was amended to include calling Reverend Jim Ayers if Pastor Gardner declined the position.
- Compensation for Interim Associate Pastor: A motion was made, seconded and passed authorizing \$30.00 per hour plus reasonable travel costs.
